# Estimates of the Uninsured

- ◆ **Lewin Group Telephone Survey of Households in South Dakota**
  - 20,307 completed interviews
  - 1,502 with uninsured persons
- ◆ **South Dakota Subsample of the March Current Population Survey (CPS) for 2001**
- ◆ **Data Adjustments**
  - Adjust for underreporting of Medicaid in CPS (23 percent underreporting)
  - Adjust CPS to match uninsured in telephone survey
- ◆ **Pool March CPS Data for 1998 to 2001 to Permit Analysis by Population Subgroup**

# Figure 1: Estimates of the Percentage of South Dakota Residents Without Health Insurance for 1987 - 2000









Distribution of Uninsured by Age



# Figure 6: Uninsured in South Dakota by Marital Status


Percentage of Marital Status Group That Is Uninsured


# Figure 7: Percentage of Various Demographic Groups That Are Uninsured

That Is Uninsured





That Is Uninsured




# Figure 8: Distribution of Uninsured in South Dakota by Family Income and Income as a Percentage of FPL

## Distribution by Family Income




## Distribution by Income as a Percentage of FPL


# Figure 9: Distribution of Uninsured by Connection to Workforce
